INFORMATION ON THE PROCESSING OF PERSONAL DATA

Your data may be disclosed to external parties to whom we entrust the performance of activities on our behalf and with whom we enter into agreements governing the processing of data.

Your personal data will be processed for the time necessary for the provision of the service and subsequently stored for administrative and accounting purposes, in accordance with the terms established by the relevant regulations applicable to each case (generally, 10 years).

The privacy regulation (Article 15-22 of the Regulation) entitles you to access your personal data and to obtain their rectification, if inaccurate or incomplete, deletion, if unlawfully processed, and portability, if provided by you and if processed automatically and on the basis of a contract or consent (Article 20). The privacy regulation also entitles you to request the restriction of data processing, if the relevant conditions are met, and to object to data processing on the grounds of your particular situation. Please note that you can withdraw any consent you may have given at any time; withdrawal does not affect the lawfulness of the processing carried out up to that point.
